Marieka Arksey is a fifth year Ph.D. student in the World Cultures Ph.D. program at the University of California, Merced. She attended the University of Toronto in Canada and earned a B.S. in Archaeological Science. She then completed her M.A. in Manchester, England in Arts, Histories and Cultures. Her current research centers on Maya cave archaeology with a specific focus on how the exteriors of caves were used as an extension of the socially and physically restricted interiors of caves for ritual performances during the time of the Maya "collapse".

He is President-Elect of the American Historical Association, to serve as president during calendar 2016.

His research includes modeling the interdependence of survey data, often assumed to be independent of each other, in fields of health and finance. He has served as a researcher and programmer in the World History Center project on African population, 1650-1950.

**Ruth Mostern** is Associate Professor of History at the University of California, Merced, where she is the chair of the Interdisciplinary Humanities Graduate Group and the co-director of the Spatial Analysis and Research Center (SpARC). She received her Ph.D. in History from University of California, Berkeley in 2003 with a specialty in Chinese History. Her book *Dividing the Realm in Order to Govern: The Spatial Organization of Song China, 960-1276 CE* was published by the Harvard University Asia Center in 2011.

**Alexandra Mountain** moved from Perth, Western Australia to Pittsburgh to enter into the PhD program at the University of Pittsburgh in 2012. She completed her Masters of History, entitled "Professionalizing the Puck: Youth Development in Canadian Major Junior Hockey" in the Spring of 2014, and became a PhD candidate in the Spring of 2015. Alexandra's dissertation thesis will examine the global professionalization of youth hockey programs from the early 1970s until the late 2000s.

Dr. Zadorozhny has chaired and served on program committees of multiple database and distributed computing conferences and workshops.
