**Daniel J. Bain** is Assistant Professor of Geology and Planetary Science at the University of Pittsburgh. He received his PhD in Geography and Environmental Engineering from Johns Hopkins University. Bain's research focuses on the identification and characterization of legacy effects, particularly those arising in urban systems and from trace metal contamination. He recently led a large team of co-authors in publishing "Legacy effects in material flux: structural catchment changes predate long-term studies" in the journal *BioScience*.

**Patrick Manning** is Andrew W. Mellon Professor of World History and Director of the World History Center at the University of Pittsburgh. From a base in African economic history he became a world historian focusing on demography, migration, and overviews of world history. His recent books include *The African Diaspora: A History through Culture* (Columbia University Press, 2009), and the second edition of *Migration in World History*, with Tiffany Trimmer (Routledge, 2012).

**Ruth Mostern** is Associate Professor of History at the University of California, Merced, where she is the chair of the Interdisciplinary Humanities Graduate Group and the co-director of the Spatial Analysis and Research Center (SpARC). She received her Ph.D. in History from University of California, Berkeley in 2003 with a specialty in Chinese History. Her book *Dividing the Realm in Order to Govern: The Spatial Organization of Song China, 960-1276 CE* was published by the Harvard University Asia Center in 2011.

**Sanjana Ravi** is a student in the Graduate School of Public Health at the University of Pittsburgh, where she is pursuing a Master's in Public Health in infectious disease management, intervention, and community practice. After graduation, she plans to join the Center for Biosecurity of the University of Pittsburgh Medical Center as a policy analyst, where she will research issues pertaining to public health emergency preparedness. In 2012, she co-authored an article examining federal compensatory mechanisms for victims of nuclear disasters.

**Filipa Ribeiro da Silva** is Assistant Professor of History of the University of Macau, China. She is a member of the Global Collaboratory for the History of Labour Relations at the International Institute of Social History (IISH) in Amsterdam. Between 2009 and 2013, Filipa was also member of the Demography Hub of the Project *Clio-Infrastructure* at the IISH. She received her PhD at Leiden University in 2009 after MA studies at the New University of Lisbon. She is author of *Dutch and Portuguese in Western Africa: Empires, Merchants and the Atlantic System, 1580-1674* (Leiden: Brill, 2011).

**Jackie Smith** is Professor of Sociology at the University of Pittsburgh and editor of the [Journal of World-Systems Research](#). Her research draws from sociology, international relations, and global studies to examine connections between globalization and popular movements, including how social movements have worked to overcome resource inequities and internal differences to build transnational alliances. Her recent books include *Social Movements in the*

*World-System: The Politics of Crisis and Transformation* (with Dawn Wiest), *A Handbook of World Social Forum Activism* (co-edited with Scott Byrd, Ellen Reese, and Elizabeth Smythe), and *Social Movements for Global Democracy*.

**Vladimir Zadorozhny** Vladimir I. Zadorozhny is an Associate Professor in the School of Information Sciences, University of Pittsburgh. He received his Ph.D. in 1993 from the Institute for Problems of Informatics, Russian Academy of Sciences in Moscow. Before coming to the USA he was a Principal Researcher in the Institute of System Programming, Russian Academy of Sciences. His research interests include networked information systems, heterogeneous information fusion, complex adaptive systems, crowdsourcing technologies, scalable personalized learning, wireless and sensor data management, query optimization in resource-constrained distributed environments, and scalable architectures for wide-area environments with heterogeneous information servers. Dr. Zadorozhny has chaired and served on program committees of multiple database and distributed computing conferences and workshops.
